

## Admission Fee Refund Rules (Class XI 2026-2027)

### FOR STUDENTS TAKING ADMISSION THROUGH ENTRANCE TEST

1. If a student takes provisional admission in any stream through Entrance Test and has paid the admission fee but has not secured the required cut-off marks as specified by the school in his/ her respective board result, in such case 100% admission fee paid by him/her will be refunded.
2. If a student takes provisional admission in any stream through Entrance Test and has paid the admission fee and secures the cut-off marks as specified by the school in his/ her respective board result and then he/ she withdraws his/ her admission **any point of time but One week BEFORE the commencement of the classes** in such case Rs.10000/- (Rupees ten thousand only) will be deducted and the rest of the amount will be refunded.
3. If a student takes take provisional admission in any stream through Entrance Test and has paid the admission fee and secures the cut-off marks as specified by the school in his/ her respective board result and then he/ she withdraws his/ her admission **Within 15 days AFTER the commencement of the classes** in such case Rs.25,000/- (Rupees Twenty five thousand only) will be deducted and the rest of the amount will be refunded.
4. If a student takes provisional admission in any stream through Entrance Test and has paid the admission fee and secures the cut-off marks as specified by the school in his/ her respective board result and then he/ she withdraws his/ her admission **AFTER 15 days to one month from the commencement of the classes** in such case 75% will be deducted and rest of the amount will be refunded.
5. If a student takes provisional admission in any stream through Entrance Test and has paid the admission fee and secures the cut-off marks as specified by the school in his/ her respective board result and then he/ she withdraws his/ her admission **AFTER one month from the commencement of the classes** no refund will be made.

1. The official date for commencement of the classes will be notified on the school website.
2. **Refund (if any) will be made online in the bank account of either father or mother for which a scanned copy of the bank cheque/ passbook has to be sent through mail.**

## Admission Fee Refund Rules (Class XI 2026-2027)

### FOR STUDENTS TAKING ADMISSION THROUGH DIRECT ADMISSION QUOTA

1. If a student takes admission in any stream through Direct Admission and then he/ she withdraws his/ her admission **any point of time but One week BEFORE the commencement of the classes**, in such case Rs. 15,000/- (Rupees fifteen thousand only) will be deducted and rest of the amount will be refunded.
2. If a student takes admission any stream through Direct Admission and then he/ she withdraws his/ her admission **within 15 days AFTER the commencement of the classes**, in such case Rs.30,000/- (Rupees thirty thousand only) will be deducted and rest of the amount will be refunded.
3. If a student takes admission any stream through Direct Admission and then he/ she withdraws his/ her admission **AFTER 15 days to one month from the commencement of the classes**, in such case 75% of the amount will be deducted and rest of the amount will be refunded.
4. If a student takes admission in any stream through Direct Admission and then he/ she withdraws his/ her admission **AFTER one month from the commencement of the classes** no refund will be made.

1. The official date for commencement of the classes will be notified on the school website.
2. **Refund (if any) will be made online in the bank account of either father or mother for which a scanned copy of the bank cheque/ passbook has to be sent through mail.**

## Admission Fee Refund Rules (Class XI 2026-2027)

### FOR STUDENTS OF JVM SHYAMALI

If a student takes the provisional admission in the streams as offered by the school, based on the internal marks and want to withdraw his/ her admission for any reason after payment of fees, the following will be the refund policy.

1. If a student withdraws his/her admission even after getting the desired stream, subject option and batch, Rs. 5000/- will be deducted from the fees paid.
2. Those students who have not been allotted their desired stream and subject option should withdraw their admission within 15 days of publication of result.
3. If withdrawal is applied **within 15 days from publication of Board Results** (only for those students who have not been allotted their desired stream and subject option) – **Full Refund**
4. If withdrawal is applied for **AFTER 15 days of the commencement of the classes**– Rs.15,000/- (Rupees fifteen thousand only) will be deducted and rest of the amount will be refunded.
5. If withdrawal is applied for **AFTER 15 days to one month from the commencement of the classes** in such case 50% of the amount will be deducted and rest of the amount will be refunded.
6. If withdrawal is applied for **AFTER one month from the commencement of the classes** – No refund will be made.

### Note:

1. The official date for commencement of the classes will be notified on the school website.
2. **Refund (if any) will be made online in the bank account of either father or mother for which a scanned copy of the bank cheque/ passbook has to be sent through mail.**

**NO REFUND will be Applicable for Wards of MECON, SAIL Units at Ranchi, JVM/ Commercial Audit etc.**
